

MUNICIPAL GENERAL ELECTIONS OF NOVEMBER 7, 2021

Vote by mail in your health care facility



YOU ARE IN A CARE CENTRE OR A HEALTH CARE FACILITY¹

You can apply to vote by mail. You can also change your entry on the list of electors remotely.

TO VOTE BY MAIL IN YOUR FACILITY

1 MAKE AN APPLICATION

Make your application by completing **sections 1 and 2 on the back of this form**, then send it to your returning officer. This form must be received **no later than October 27, 2021**.

2 YOU MUST BE ENTERED ON THE LIST OF ELECTORS OR MODIFY YOUR ENTRY?

Also complete **sections 3 and 4 of this form**, then send it to your returning officer. This form must be received **no later than**

To be entered on the list of electors or to make a change of address, you must **attach to your application a photocopy of two documents** that contain:

- 1 Your name and your date of birth**
(birth certificate, health insurance card, passport, etc.)
- 2 Your name and the address of your health care centre or facility**
(centre's certificate, driver's license, telephone or electricity bill, etc.)

You can also ask a staff member at your centre to certify your identity by signing the declaration on the back of this form.

3 MAKE SURE YOU RECEIVE YOUR BALLOT PAPERS

If you have not received your ballot papers a few days after they have been sent, contact your returning officer. He or she will be able to send them again.

To be valid, your ballot papers must be received at the returning officer's office **no later than 4:30 p.m. on November 5, 2021**.

1. Only the electors domiciled or living in a hospital centre, a CHSLD, a rehabilitation centre or in a private seniors' residence listed in the register established under the *Act respecting health services and social services* can take advantage of these special measures.
2. A person is under curatorship if he or she has been found by a court to be totally and permanently unfit to care for himself or herself and to administer his or her property.
